This periodical is distributed free of charge to lawyers, insurers, and interested parties corresponding to the release date of Statistics Canada's *Consumer Price Index* ("CPI") and unemployment rate data and focuses on a topic of interest relating to forensic economics. More than 280 issues of this periodical have been distributed. Approximately 100 editions of the periodical are on deposit at the Government of Canada's *Library and Archives Canada* (LAC), pursuant to their request.

Each edition also supplies a chart for inflating non-pecuniary damages by Statistics Canada's CPI, every year since 1978, using the rolling average method with Canada-wide data.¹² To update non-pecuniary damages by inflation online, go to www.browneconomic.com > **Non-Pecuniary Damages Calculator™** (free to use).

On the final page of each issue, Brown Economic supplies the month-over-month rate of inflation for several *Census Metropolitan Areas* ("CMA"): Vancouver, Toronto, Ottawa, Montreal, Edmonton, Calgary, Halifax, St. John's, Saint John, Charlottetown and Canada-wide; and the monthly unemployment rate for the same regions.
